## ORDINANCE 2025-08-822

# AN ORDINANCE OF THE BOROUGH OF PINE BEACH PROHIBITING PARKING ON PORTIONS LINDEN AVE AND AMENDING CHAPTER 166 OF THE CODE OF THE BOROUGH OF PINE BEACH

*WHEREAS*, Chapter 166 of the Code of the Borough of Pine Beach establishes traffic regulations withing the Borough and the penalties for violations thereof, and;

WHEREAS, it has been determined that certain vehicular parking practices on the one-hundred and two-hundred blocks of Linden Avenue located near the Pine Beach Elementary School may pose a danger to both pedestrian and vehicular traffic during times when school is in session:

WHEREAS, the Mayor and Council of the Borough of Pine Beach, in order to enhance public safety around the school area wish to amend Chapter 166.

**NOW, THEREFORE, BE IT ORDAINED,** by the Mayor and Council of the Borough of Pine Beach, County of Ocean, State of New Jersey, that Chapter 166 of the Code of the Borough of Pine Beach is hereby amended as follows:

# § 166-18. Parking prohibited certain hours.

No person shall park a vehicle between the hours specified in Schedule XIV (§ 166-42) of any day, unless otherwise indicated, upon any of the streets or parts of streets described in said Schedule XIV, attached to and made a part of this chapter.

# § 166-42. Schedule XIV: Parking Prohibited Certain Hours.

In accordance with the provisions of § 166-18, no person shall park a vehicle between the hours listed upon any of the following described streets or parts of streets:

Name of Street	Side	Hours/Days	Location
Monument Road	East and West	8:00 a.m. to 10:00 a.m.; 2:00 p.m. to 4:00 p.m./everyday school is in session	Between Pennsylvania Avenue and Linden Avenue
Pennsylvania Avenue	North	6:00 a.m. to 10:00 a.m.; 2:00 p.m. to 5:00 p.m./school days	From Motor Road to westerly borough line
Linden Avenue	North and South	8:00 a.m. to 10:00 a.m.; 2:00 p.m. to 4:00 p.m./everyday school is in session	From Motor Road to westerly borough line

Penalty for 1st offense shall be \$35. For a second or subsequent offense, the penalty shall be not less than \$35 and not more than \$50.

**SECTION 1.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 2.** If any section, subsection, sentence, clause, phrase of portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 3.** This ordinance shall take effect after second reading and publication as required by law.

# AN ORDINANCE OF THE BOROUGH OF PINE BEACH, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 169 OF THE CODE OF THE BOROUGH OF PINE BEACH ENTITLED WATER

BE IT ORDAINED by the Borough Council of the Borough of Pine Beach, County of Ocean, State of New Jersey, as follows:

SECTION 1. That Chapter 169 of the Code of Pine Beach entitled "WATER" shall be amended as follows:

- A. ARTICLE III entitled "Rent and Charges" shall be supplemented and amended as follows:
- 1. Chapter 169-13 "Bills for usage; disputes" "Terms of Payment" of the code of the Borough of Pine Beach to read as follows:
  - A. Meters will be read and billed quarterly for all water consumed during the previous period, in accordance with the Borough's filed rates.
  - B. Bills shall become delinquent 10 days after they are due. Unpaid water bills shall become a lien upon the property involved.
  - C. Customers with no water usage will be responsible for the annual minimum fee paid quarterly.
  - D. In cases where the meter has been found to be registered inaccurately or has ceased to register, the quantity of water used may be determined by the average registration of the meter in a corresponding past period when in order.
  - E. In case of a disputed bill involving the accuracy of the meter, such meter shall be tested upon the request of the customer in conformity with the provision of the rules and regulations pertaining to water service utilities of the Public Utility Commission of the State of New Jersey. Should the meter tested be found to have an error in the registration in excess of 3% the bills will be corrected accordingly.
  - F. The quantity recorded by the meter shall be considered the amount of water passing through the meter, which amount shall be conclusive as to both customer and the Borough.
- 2. Chapter 169-16 "Annual Rates," shall be supplemented and amended to read as follows:
  - A. The annual water rates, effective January 1, 2026 shall be as follows:
- (1) Distribution Rate:
  - (a) Annual Minimum is \$260.00 payable in four quarterly equal installments of \$65.00 for distribution fees.
  - (b) Properties with water service turned off shall still be responsible for the quarterly distribution rate.

#### (2) Usage Rate:

a. Usage will be billed at a rate of \$2.50 per thousand gallons (1,000) up to one hundred thousand gallons (100,000) per quarter for consumption at an increase of \$.25 per year following 2026 until 2030. The rates are as following for consumption use under one hundred thousand gallons (100,000) per quarter:

Year	Rate of usage per thousand gallons (up to 100,000 gallons) per quarterly read
2026	\$2.50
2027	\$2.75
2028	\$3.00
2029	\$3.25
2030	\$3.50

b. In the case of a user whose quarterly usage exceeds one hundred thousand (100,000) gallons, the rates shall be as set forth as follows:

Year	Rate of usage per thousand (for excess of 100,000 gallons) per quarterly read
2026	\$3.50
2027	\$3.75
2028	\$4.00
2029	\$4.25
2030	\$4.50

SECTION 2. This ordinance shall become effective January 1, 2026

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 4. Pursuant to the provisions of N.J.S.A. 40:69A-181(b), this ordinance shall take effect twenty (20) days after its final passage by the Borough Council and approval by the Mayor where such approval is required by law.
