At the public hearing any party wishing to comment on the report may do so or may submit written comments to the Land Use Board prior to the public hearing date. After public comment at the public hearing, the Land Use Board may take formal action on the adoption of the amended element of the Borough of Pine Beach Master Plan.

A copy of the amended Master Plan Element will be on file with the Borough Clerk's office ten (10) days prior to the public hearing and to be reviewed Monday-Friday 9 am-4 pm at the Pine Beach Municipal Building, 599 Pennsylvania Avenue, Pine Beach, NJ 08741.

RESOLUTION NO. 2025-06

RESOLUTION OF THE LAND USE BOARD OF THE BOROUGH OF PINE BEACH, IN THE COUNTY OF OCEAN, APPROVING AND ADOPTING A HOUSING ELEMENT AND FAIR SHARE PLAN TO SATISFY THE BOROUGH'S FOURTH ROUND AFFORDABLE HOUSING OBLIGATION

WHEREAS, on March 20, 2024, Governor Murphy signed into law P.L. 2024, c.2, which amended the 1985 New Jersey Fair Housing Act ("Amended FHA"); and

WHEREAS, the Borough adopted a "binding resolution" committing to a Present Need obligation of zero (0) units and a Prospective Need obligation of three (3) units based on the Township's Affordable Housing Planner, Mark Rohmeyer, P.E., P.P., C.M.E. ("Planner")'s calculations using the methodology in the Amended FHA; and

WHEREAS, in accordance with the Amended FHA and the Administrative Office of the Court's Directive No. 14-24, the Borough filed a timely Fourth Round Declaratory Judgment complaint ("DJ Complaint") with the Affordable Housing Dispute Resolution Program ("Program") on January 16, 2025, along with its binding resolution; and

WHEREAS, the filing of the DJ Complaint gave the Borough automatic, continued immunity from all exclusionary zoning lawsuits, including builder's remedy lawsuits, which is still in full force and effect; and

WHEREAS, the New Jersey Builders Association ("NJBA") and Fair Share Housing Center ("FSHC") filed timely challenges to the DJ Action; and

WHEREAS, the Honorable Julio L. Mendez, J.S.C. (Ret.) was assigned to manage the proceedings, host settlement conferences, and make recommendations to the Honorable Sean J. Gertner, J.S.C., the Mount Laurel Judge of Ocean Vicinage; and

WHEREAS, the Borough and FSHC reached an agreement that was put on the record at a settlement conference that took place on March 20, 2025 before Judge Mendez; and

WHEREAS, NJBA did not participate in the settlement negotiations, nor did it object to any settlement reached between the Borough and FSHC; and

WHEREAS, on April 15, 2025, Judge Gertner prepared an order fixing the Borough's obligation at 0 for the Present Need and thirty (30) for the Prospective Need, and authorized the Borough to proceed with preparing and adopting its Housing Element and Fair Share Plan for the Fourth Round ("Court Order"); and

WHEREAS, per the Amended FHA, Directive 14-24 and the Court Order, the Planner drafted a Fourth Round Housing Element and Fair Share Plan ("Fourth Round HEFSP"); and

WHEREAS, pursuant to N.J.S.A. 40:55D-28, the Borough of Pine Beach Land Use Board ("Board") may prepare and adopt or amend a master plan or component parts thereof, after a public hearing, to guide the use of lands within the municipality in a manner which protects health and safety and promotes the general welfare; and

WHEREAS, upon notice in accordance with N.J.S.A. 40:55D-13, the Board held a public hearing on June 3, 2025 on the adoption of the Fourth Round HEFSP as required by the Municipal Land Use Law. Said hearing was attended by the Planner, who was duly sworn, and provided testimony regarding the Fourth Round HEFSP; and

WHEREAS, the hearing was opened to the public; and

WHEREAS, the Board determined that the Fourth Round HEFSP is consistent with the goals and objectives of the Borough's current Master Plan, and that adoption and implementation of the Fourth Round HEFSP is in the public interest and protects public health and safety and promotes the general welfare.

NOW, THEREFORE, BE IT RESOLVED by the Land Use Board of the Borough of Pine Beach, County of Ocean, State of New Jersey, that the Land Use Board hereby adopts the Fourth Round HEFSP, attached hereto as Exhibit A.

BE IT FURTHER RESOLVED that the Land Use Board of the Borough of Pine Beach adopts this resolution to memorialize the action taken by the Board following the close of the public hearing on June 3, 2025.

BE IT FURTHER RESOLVED that the Secretary is hereby authorized and directed to transmit a copy of the adopted Fourth Round HEFSP and a certified copy of this Resolution to the governing body together with this Board's request that the governing body endorse the adopted Fourth Round HEFSP.
