PUBLIC HEARING ON ORDINANCE: ORDINANCE 15-04-728

AN ORDINANCE OF THE BOROUGH OF PINE BEACH, COUNTY OF OCEAN, STATE OF NEW JERSEY, ENTITLED "UNIFIED ELECTRONIC REPORTING SYSTEM FOR DEALERS IN PRECIOUS METALS AND OTHER SECONDHAND GOODS".

This ordinance was introduced on March 11, 2015 and published in the Asbury Park Press on March 20. It is posted on the Bulletin Board of the Municipal Building and copies are available.

Mayor Cuneo read the title of the ordinance and called for a public hearing on the proposal:

Mr. Russo asked for an explanation, and Mr. Wieck explained that this is a program with the Ocean County Prosecutor to unify supervision and policing secondhand goods and dealers in precious metals procedures for the entire county. All police departments will follow the same regulations and will be able to look up on line to check on stolen property. This is in the best interests of the community.

MAYOR'S COMMENTS

Mayor Cuneo mentioned that Chief Fisher has assessed the exterior of the building and there is no sign to indicate where the police department is located. Chief Fisher felt it was important to identify the location of the police department, and he had a sign in the form of the police patch designed. The Mayor showed the sign to the audience. It will be affixed at the end of the ramp to the police department. Chief Fisher is looking to have a sign placed at the top of the ramp by the parking lot also.

Mayor Cuneo announced that the Borough is closing out the U.S. Department of Agriculture waterfront development loan. It took 20 years to get the work done and cost less than the original estimate. Our engineer Jack Mallon did a great job, and the contractor did a phenomenal job.

The new well is almost finished, the original well number one failed several years ago.

Spring sports are starting, and the Mayor urged all to enjoy watching the young athletes.
