AN ORDINANCE OF THE BOROUGH OF PINE BEACH, COUNTY OF OCEAN, STATE OF NEW JERSEY SUPPLEMENTING AND AMENDING CHAPTER 22 OF THE CODE OF THE BOROUGH OF PINE BEACH ENTITLED "OFFICERS AND EMPLOYEES"
