

**BOROUGH OF PINE BEACH
REGULAR MEETING
December 14, 2011**

A regular meeting of the Mayor and Council of the Borough of Pine Beach took place on December 14, 2011 at 7:30 PM at the municipal building, 599 Pennsylvania Ave.

Mayor Boyle called the meeting to order and read the STATEMENT OF ADEQUATE NOTICE:

REVENUE REPORTS were read by Mrs. Steib and approved following a motion by Mr. Cuneo and seconded by Mr. Wieck.

Mrs. Steib explained that the traffic control receipt was for the police presence during road construction. A portion of the money pays the police and the balance is provided to the Borough for expenses and use of the police vehicle.

COMMITTEE REPORTS:

Chief Sgro reported that for the month of November the police department responded to 235 calls for service.

Ptl. Longhitano was nominated by our police department and was awarded the Ocean County Police Traffic Safety Officer's Association's Kimberly Smith Ames award. Ptl. Longhitano was nominated because he leads our department in DWI arrests, with 26 in the past year and because in August 2010 he stopped Christopher Merz, the very same driver that killed Kimberly and her unborn child and placed him under arrest for again driving while intoxicated. He was initially stopped for driving 52 in a 35 mph zone and after it was determined he had been drinking and breath testing put his blood alcohol content at .18%. On behalf of the entire police department, Chief Sgro wished all a safe and happy holiday season.

Mr. Cuneo moved the Police, municipal court, water and sewer utility, building inspector, public works reports approved as submitted and was seconded by Mr. Budesca.

Mr. Budesca mentioned that the municipal court income is not as high as it has been, and that the police force has done such a great job in enforcement that word is out to be careful in Pine Beach.

Mayor Boyle thanked Ptl. Longhitano for doing such a great job.

Resolution 11-105, Accepting executive session minutes from 2011 was moved by Mr. Abatemarco and seconded by Mr. Polhemus.

Mr. Cuneo commented that there were a lot more executive sessions than he remembered doing.

Resolution 11-106, Requesting DEP fees be waived for municipalities was approved following a motion by Mr. Cuneo and seconded by Mr. Polhemus.

Mayor Boyle stated that this resolution was prompted by statements made by our Engineer, John Mallon, at an Ocean County Mayor's Association meeting presentation by the DEP. The fees charged are charged for public projects and we are asking that they will be waived for municipal projects.

Resolution 11-109, Change Order #1A for Hillside Ave. roadwork was approved by a motion by Mr. Budesa and seconded by Mr. Abatemarco.

Mayor Boyle explained that this is a change order for final quantities in the roadwork on Hillside Ave. This was the project where a sewer back up occurred and it is an insurance matter. This is not authorizing a payment, but rather a change order. Earle Asphalt has acknowledged their obligation, and before the final payment is made we will be sure it is taken care of.
