# NJ Green Acres Program- Jake's Law: Vista Park Inclusive Playground

The Mayor reads the following statement to the Council & Public:

This public hearing notice was published in the Asbury Park Press on January 9<sup>th</sup>, 2025 and has met the obligations for the Public Notice Requirements. The Concept Plan Checklist as well as copies of the presented Impact Analysis, Mitigation Measures, Alternatives to the Proposed Action sections of the Environmental Impact Assessment are located on the front table, on our website pinebeachborough.us, and in the Clerk's office from 9-4pm M-F.

The Clerk presents the application to the public with the following statements:

In the packets provided there are the following for your reference and following along. There are a few items we would like to present to the Public tonight. As well as invite the public to view items located at the front of the meeting room for review at your leisure.

### **Project Description:**

The existing physical site characteristics and features of the project location include a gently sloped grade, asphalt walkways, concrete slabs, curbing surrounding a mulch playground area and existing outdated playground that was constructed in 2002 and in poor condition. There is a park building which contains bathrooms and a snack area adjacent to the playground. There are existing parking spaces between the road and playground which include (2) handicap parking spaces.

## **Impact Analysis:**

Overall, we anticipate minimal impacts from the proposed project as the proposed playground is replacing an existing playground. No impacts to grading, lighting, etc. The only impact would be positive, for example we would be relocating (2) shade trees and likely adding several more, and we would have a newer and safer playground that is all inclusive. No other significant impacts are anticipated.

The complete impact analysis is included in the public package for tonight's Public Hearing.

## **Mitigation Measures:**

Landscaping will be added to reduce the potential impact of increased noise. No other adverse impacts anticipated.

There are no alternatives planned to the Proposed Action sections as the proposed project site at Vista Park is ideal and replacing an existing failing playground within the approximate same footprint. Therefore, we can preserve other natural areas of the Municipality.

The Mayor makes a motion to open the Public Hearing for Public Comments.

## Charlene Carney - 333 Avon Rd., Pine Beach

Mrs. Carney comments that she has grandchildren who utilize this playground and states the condition of the playground is unacceptable. She is very happy to have the Mayor & Council pursuing these repairs. She states that an inclusive playground would be a wonderful asset to Pine Beach and the senior community who accompany their grandchildren to the park. She would like to see even surfaces for wheelchairs, walkers, canes, and strollers. She also likes that the plan includes a shaded area as currently the summer heat is unbearable. Mrs. Carney continues that being a member of Pine Beach Borough for many years she has witnessed Mothers in our area struggle with disabilities themselves or with their children and is proud that Pine Beach is welcoming inclusive areas into our town.

### Paul Walters - 333 Wayne Ave., Pine Beach

Mr. Walters begins that he frequents the Vista Park playground and this new equipment is very exciting for our area. Mr. Walters states that the community supports this plan and will look forward to utilizing the inclusive equipment.
