Paul Walters – 333 Wayne Ave.

Mr. Walters asks for an update on the paving projects. Mayor states the County Paving project is still going on, we are waiting for them to complete all the work.

Jane Cox- 901 Motor Rd.

Ms. Cox asks if there are certain roads being paved.

Mayor Cuneo responds West on Pennsylvania Ave is the Borough's project and the East of Motor Rd side is the County, Motor Rd, Springfield, and Prospect Ave are all County.

Kathleen Anen- 729 Riverside Dr.

Mrs. Anen asks if there is any discussion for adding more parking to Vista Park for soccer fields. Mayor Cuneo asks where we could put this parking and reminds there is a Borough lot at Hillside Ave for over flow a block away. Mrs. Anen complains of the high volume parking on Lincoln Ave and is concerned the emergency vehicles would not be able to get through. The Mayor requests she calls the Police department when she witnesses a hazard as such.

Mrs. Anen then asks if there was any more discussion on the Owner Occupancy Ordinance. Mr. Keesling lets her know we are working on the legality of the Ordinance and would appreciate her feedback in a private setting such as email.

Ms. Cox asks if there is any news on the lot (referencing the undersized lot on Merion and Motor Ave.) Mayor Cuneo advises that there have been summons issues and is being cleaned up. As far as building progression, no updates. Ms. Cox asks if we know how long the legal process of this will be, the Mayor states no estimate of time.

## **COUNCIL COMMENTS**

Mr. Newman thanks everyone for coming out, the message board is out reminding everyone of trunk-ortreat. Set up by 12:30pm October 18<sup>th</sup> 1-4pm we have 35 excited "trunkers". This year the event will have vendors selling crafts, food trucks, a pumpkin patch for anyone under twelve, pony rides, petting zoo and lots more! We welcome everyone to come and join us.

Mr. Polhemus thanked everyone for coming out tonight. He congratulated Cristal on her new appointment and states he knows she will do a wonderful job and bring innovation to this department. Mr. Polhemus then welcomes out High School interns and encourages them to come forward with any questions; we are happy to share any knowledge we have up here. ### MAYOR'S COMMENTS

Mayor Cuneo again welcomes the interns and encourages them to ask questions and use Hannah and Cristal to learn all they can while here. He shares how awesome Fire Fest was last weekend and the amazing weather for the first time in three years. The Chief was here on Monday night and shared how special it is to represent the Fire Co on their 100<sup>th</sup> year anniversary as well as the Boroughs 100th anniversary. Less than thirty percent of the residents donate to the Fire Company, yet they answer one hundred percent of our calls without question. Please contribute and talk to your neighbors as well. \$100 for 100 years, but anything you can contribute truly helps.

Mayor Cuneo reminds everyone that the year is ending as well as our 100-year celebrations, the PBPS has holiday items for sale as well as pre-order for the commemorative book.

The Borough met with the state's representative for Affordable Housing as well as the objector, Fair Share Housing. We will amend the Fair Share Housing Element and re-submit it for approval. Many lawsuits were thrown out by judges because Affordable Housing is a voluntary program. If it is voluntary the question is then why municipalities are being held to the state's requirements and units assigned for housing.
