ORDINANCE 2025-04-818

BOND ORDINANCE PROVIDING FOR THE IMPROVEMENT OF GRANT AVENUE AND PENNSYLVANIA AVENUE AND PURCHASE OF AN ELECTRONIC MESSAGE BOARD FOR AND BY THE BOROUGH OF PINE BEACH, IN THE COUNTY OF OCEAN, NEW JERSEY, APPROPRIATING \$703,000 THEREFOR, INCLUDING A NEW JERSEY DEPARTMENT OF TRANSPORTATION GRANT IN THE AMOUNT OF \$384,725 AND A COMMUNITY DEVELOPMENT BLOCK GRANT IN THE AMOUNT OF \$40,000, AND AUTHORIZING THE ISSUANCE OF \$277,275 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF

This ordinance will be advertised in the Asbury Park Press May 15th and will have a public hearing on May 27th, 2025 at the regular scheduled Council Work meeting at 6:30pm.

Mayor Cuneo reads the Ordinance 2025-04-818 in summary and looks for a motion to introduce the ordinance as submitted, Mr. Wieck makes a motion, seconded by Mr. Newman.

Mr. Keesling comments that the bond ordinance before the Council today supports multiple grant projects that he is in favor of but also authorizes the funding of approximately \$20,000 for a digital message board. Mr. Keesling believes that this messaging board does not add to the residents' quality of life and no residents beyond a few on the Council have voiced a desire for the purchase. The other means of communication are seen as sufficient for Mr. Keesling for the Borough. Mr. Keesling feels that other departments are in need for basic operational equipment or the third bulk pick-up for residents would improve the quality of life for our residents more. In conclusion, Mr. Keesling votes no for Ordinance 2025-04-818.

This ordinance has successfully been introduced and will be on the agenda for public hearing on May 27th, at 6:30 pm at the Borough Hall.

MAYOR'S COMMENTS

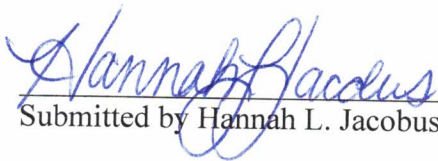
Mayor Cuneo states that in previous years the Memorial Day ceremony is well attended and thanks the community and hopes they continue to come out for this year's ceremony.

Mayor Cuneo announces that the Vista Park all-inclusive playground has been awarded grant funding. With this year's budget it is always a work in progress, the Mayor thanks the Council for this year's participation and hopes to bring this year's budget tracker to next year's process. He recognizes that the Borough employees wear many different hats to make this budget work and would like to personally thank them for the work they do.

The mayor continues that the estimated tax bills are limited to what we can project and hope we get close to the number but this year they can be worse with the school tax increase. In brighter news, schools sports are coming to the end of their seasons, and the Mayor encourages the public to get out and support our sports teams. Thank you for the public for coming out tonight and looking forward to seeing everyone at the Memorial Day ceremony. Summer is just beginning with the PBPS event June 21st, PBYC regatta, reminder to drive slow summer is in full swing.

Mr. Wieck adds that with the Grant for the Vista Park All-Inclusive playground there will be a committee formed to maintain and preserve these new investments.
