BOROUGH OF PINE BEACH WORK MEETING October 20, 2025

The Mayor and Council of the Borough of Pine Beach held a meeting on October 20, 2025 in the Municipal Building, 599 Pennsylvania Ave. at 6:30 PM. Mayor Cueno called the meeting to order and read the STATEMENT OF ADEQUATE NOTICE:

UNFINISHED BUSINESS

Beachwood EMS- Shared Service agreement

Mr. Saxton had a conversation with Chief Matyas, they are requesting \$12,500 with a 4% increase per year.

Mr. Keesling asks Linda Covello, CFO, what we budgeted for in 2025. Linda responds \$16,000.

Mayor Cuneo shares that based on the numbers provided by the Chief, 14% of calls are for Pine Beach. Mayor agrees that paying one third of LOSAP as per our standing Ordinance and one third of insurance is no problem. His concerning factors are that the budget for Beachwood for EMS was expanded in 2024. Spending every nickel of a budget line is not something the Borough of Pine Beach practices. The beginning number is too high from no annual contribution to \$12,500 and 4% is higher than our cost-of-living increase.

Mr. Saxton if Pine Beach is 14% of the calls like the information provided shows that we are floating the equipment reimburse and gas usage for the rest of the County.

Mr. Newman asks for Council to agree to \$9,500 plus LOSAP plus insurance.

Mayor Cuneo confirms his suggestion is \$8,000 plus LOSAP plus Insurance.

Mr. Keesling suggests reaching out to Chief Matyas with our concerns of the high request and what we are willing to negotiate to. The Borough is trying to be a good partner, as we have for many years, and will consider the impacts are with not having the \$12,500.

Mr. Polhemus states the negotiations start high, but the Borough has to consider what can realistically afford for these services.

Mrs. McGee expresses that we cannot look at the call volume, we must look that when needed they arrive.

Mr. Newman suggests \$8,650 plus \$250 annual increase.

Mayor Cuneo agrees that there is a big difference between previous communication from EMS leaders and them no billing out for services. At previous meetings we have had representatives in to discuss with a request to have transparency and have Mayor and Council review their financial and accounting. The Borough of Pine Beach has paid for buildings, furniture, and excreta. \$8,000 plus LOSAP plus insurance is a fair contribution to services provided to our community.

Mr. Newman confirms his request for \$8,650 plus LOSAP, plus insurance and plans for a vote at the next Council meeting.

NEW BUSINESS

Council reviews the Best Practices Survey 2025.
