B. WIECK – Council President

Mr. Wieck gives an update for the Mayor in his absence. R. NEWMAN

Mr. Newman reports that PBPS had a meeting to discuss some of the upcoming events and the support they will be giving. Their event on June 21st will be a large celebration with food trucks, craft vendors, kids zone, and two live bands. PBPS is also helping support the Borough's Trunk-or-Treat event and the Tree Lighting. Mr. Newman states they are fully committed to our community, we are looking forward to these events. Mr. Newman would like to see improvements to the Walling Field area with an addition of playground equipment, he is working with the Engineer to look into upcoming grant opportunities.

He is going to compare the solar lighting with traditional lighting and report more at a later date. The personnel committee and the Police Department are continuing contract negotiations. Mr. Wieck states this is a great opportunity for state reporting and DEP communications to be held internally and happy Seth has met the requirements.
