The Mayor then reads a *Proclamation in Honor of The Borough of Pine Beach Centennial* from the Office of the Mayor.

The Mayor welcomes the representative from Senator Chris Smith's Officer, Jeff Sagnip. Jeff reads a wonderful dedication to the Borough that was read on the floor of the Senate.

Mayor Cuneo then asks Senator Amato and Assemblyman Rumpf to speak. Dedicating a Proclamation from both of their offices to the Borough. Senator Amato, prior Mayor of Berkeley Township, claims Pine Beach is a hidden gem that he is sorry we ever broke away from Berkeley. Assemblyman Rumpf commemorates the "Pearl of the Toms River" and states Pine Beach is the embodiment of small-town America, hardworking people. He wishes our community continued safety and prosperity with his sincere congratulations on this Centennial milestone.

Chuck Laing, former Pine Beach resident of 50 years, states it is an honor to be here tonight and congratulates everyone. The Mayor and Council thank Chuck for being here tonight, it means a lot.

Dorothy Kulina of 901 Motor Rd. asks the Mayor and Council for clarification on the discussion of Ocean Gate and a shared service agreement for the Police Department. The Mayor clarifies that the intentions are not to get rid of the Pine Beach Police Department, we want our own Police Department, but he would be remiss as the Mayor of Pine Beach to not listen to Ocean Gate and Beachwood if it in anyway can benefit us. At

this point the Mayor & Council are listening to proposals, and it must benefit all. This big of a decision would be a vote and the Mayor assures he will not spend any money if there is no benefit. This idea was looked at 15 years ago and would cost more money, but we do have to look at these items in our positions. Miss Kulina states she loves our department, and the Mayor understands and states he is looking at the longevity and community police service.

Jim Rillo of 516 Pennsylvania Ave. asks the Mayor and Council to consider more then the bottom dollar for the Police Decision, he encourages this decision to benefit the Borough of Pine Beach, Mr. Rillo also congratulates everyone on this Centennial Celebrations.

John Kubilewicz, President of the PBVFC shares that the Fire Company is also celebrating their 100 Year Anniversary and will be celebrating with the PBPS in June as well as their golf outing, June 4<sup>th</sup>.

The Mayor thanks everyone for coming out tonight and asks George Roksvaag to step forward with the rest of the Preservation Society to cut the cake and start the celebrations.

Hearing no other comments, the Mayor looks for a motion to adjourn. Mr. Keesling makes a motion to adjourn the meeting, the motion is seconded by Mr. Newman, all were in favor.
